Be it enacted by the Quorum Court of the County of Faulkner, State of Arkansas, an RTER Ordinance to be entitled: An Organizational Ordinance for the 2017-2018 Faulkher TY CLERK County Quorum Court.

WHEREAS, Act 130 of 1975 of the Arkansas General Assembly requires the County Quorum Courts to meet monthly at a time and place specified by ordinance and authorizes the calling of special meetings.

#### Section 1: Regular Meeting

The regular monthly meeting of the Faulkner County Quorum Court shall be held at 7pm on the third Tuesday of each month in Courtroom "A" of the Faulkner County Courthouse.

If Courtroom "A" of the Faulkner County Courthouse is not available for a meeting, the Quorum Court shall hold its regular meeting at some other convenient location within the city of Conway as designated by the Faulkner County Judge.

#### **Section 2: Special Meeting**

Special meetings of the Faulkner County Quorum Court may be called by the County Judge or by a majority of the elected Justices of the Peace upon at least twenty-four (24) hours' notice.

Such notice shall include the time, date, and place of the special meeting, provided that the meeting shall not be held outside of the boundaries of Faulkner County. The notice shall also include the general purpose of the meeting.

Notice of a special meeting given at any regular or special meeting shall constitute due notice to the members present. The County Clerk shall be responsible for providing timely notice to absent members, as well as giving public notice, containing the information listed above.

Notice of a special meeting called by a majority of the Justices shall be accomplished by one member notifying the County Clerk in writing, if time permits. Such notice shall also include the names of each Justice making up the majority calling the meeting. The County Clerk shall be responsible for notifying the County Judge and other Justices in writing, if time permits, and giving due public notice.

#### Section 3: Rescheduling a Regular Meeting

Regular meetings of the Faulkner County Quorum Court shall be rescheduled only by a resolution approved by a majority of the elected Justices of the Peace at a regular or special meeting or by petition signed by a majority of the elected Justices of the Peace.

The resolution or petition shall include the time, date, and place of the rescheduled meeting: provided that the meeting shall not be held outside the boundaries of Faulkner County.

Any petition rescheduling a regular meeting shall be delivered to the County Clerk at least twenty-four (24) hours before the regular or rescheduled meeting, whichever shall be sooner.

Notice of a rescheduled meeting given at any regular or special meeting of the Quorum Court shall constitute due notice to the members present. The county Clerk shall be responsible for given timely notice to absent members as well as giving public notice.

If a regular meeting of the Quorum Court is rescheduled by petition, the County Clerk is responsible for giving timely notice to absent members as well as giving public notice.

#### Section 4: Secretariat

In accordance with A.C.A. §14-14-902, the County Clerk or her designee is appointed as Secretariat of this Court. The duties of the Secretariat shall be as stated in A.C.A. §14-14-903(a)(3). She shall record all full court and committee meetings, with the exception of executive sessions.

### Section 5: Legal Counsel

The County Civil Attorney is hereby designated as legal counsel for the Quorum Court pursuant to A.C.A. §14-14-902(b).

### Section 6: Procedural Rules

The Democratic Rules of Order are hereby designated as the controlling Rules of Procedure for all meetings of the Faulkner County Quorum Court, pursuant to A.C.A. §14-14-904(e).

#### Section 7: Committees

The following Committees, with 5 members each, are hereby established to serve the Faulkner County Quorum Court:

Budget & Finance

Transportation & Infrastructure

Courts and Public Safety

Personnel

#### Section 8: Voting

Voting on all issues before the Court will be made by audible roll call vote, in alphabetical order, subject to the Rules of Procedure adopted above.

- Section 2: A user's selection of this link shall transfer control to a listing of all currently vacant appointed positions on all Faulkner County administrative boards and commissions.
- Section 3: Information about each vacant position shall include the appointment period, a brief description of the function and duties of a board member, residency requirements, an application form and any other information unique to a board appointment.
- Section 4: Vacancies on all County administrative boards or commissions shall be posted on the county's website and social media for 14 days prior to the appointment date.
- Section 5: Citizens may submit an application to the County Judge's office in order to be considered for any vacancy to an administrative board or commission.



Be it enacted by the Quorum Court of Faulkner County, State of Arkansas. An Ordinance to be entitled: An appropriation Ordinance to establish the annual operating budget for calendar year 2018.

## Section 1: ANNUAL BUDGET ADOPTED BY REFERENCE.

The annual budget for calendar year 2018 identified as "2018 Annual Budget, Faulkner County, Arkansas", dated December 19, 2017 is hereby adopted by reference. A copy of said budget shall be filed in the Office of the County Clerk and shall be available for inspection and copying by any person during normal business hours.

## Section 2: NONRESTRICTED EXPENDITURE CATEGORIES.

Expenditures of funds appropriated by this Ordinance shall not be restricted to the line item expenditure codes comprising the four major categories of expenditures - Personal Services, Supplies, Other Services and Charges and Capital Outlays, but shall be restricted to office/departmental expenditures.

#### Section 3: EXPENDITURE RESTRICTED TO SPECIFIED FUNDS.

No expenditure of appropriated funds shall be made from any fund other that the fund specified in the Ordinance or an amendment thereto.

#### Section 4: TRANSFERS.

Any transfer of monies between the various funds of the County or between the four major categories of expenditures - Personal Services, Supplies, Other Services and Charges, Capital Outlays – shall be made only with prior approval of the Faulkner County Quorum Court. Provided, however, all transfers budgeted for in the annual budget shall be exempt from the provisions of this section.

## Section 5: REPEALER.

All ordinances and parts of ordinances in conflict with this ordinance are hereby repealed. If any provision of this ordinance or the application thereof to any person or circumstance is held to be invalid, such invalidity shall not affect other provisions or application of the ordinance which can be given effect without the invalid provision or application, and to this end the provisions of this ordinance are declared severable.

#### Section 6: EFFECTIVE DATE.

This ordinance is adopted to comply with the provisions of A.C.A. § 14-14-907 and shall be effective as of January 1, 2018.
