**ORDINANCE 19-01**

**BE IT ENACTED BY THE QUORUM COURT OF THE COUNTY OF FAULKNER, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED: AN ORGANIZATIONAL ORDINANCE FOR THE NEW QUORUM COURT.**

WHEREAS, the term for the new Quorum Court began on January 1, 2019, and an organizational ordinance for the new Quorum Court is needed, and,

WHEREAS, the Quorum Court desires to establish its regular meeting schedule by ordinance pursuant to Arkansas Code Annotated § 14-14-904, and the Court finds that it is in the best interests of the Court to do so.

**NOW, THEREFORE, BE IT ORDAINED BY THE QUORUM COURT OF FAULKNER COUNTY, ARKANSAS, THAT:**

Article 1: Unless modified by subsequent ordinance, the regular monthly meeting of the Quorum Court shall hereafter be held on the Third (3<sup>rd</sup>) Tuesday of each month at 7:00pm.

Article 2: The regular monthly meetings of the Quorum Court shall be held at the Faulkner County Courthouse, Courtroom A. If Courtroom A is unavailable, the Justices of the Peace will be timely notified of the meeting location by the Secretariat.

Article 3: The regular monthly meeting of the Budget and Finance Committee shall be held on the Second (2<sup>nd</sup>) Tuesday of every month at 6:00pm.

Article 4: The regular monthly meetings of the Budget and Finance Committee shall be held at the Faulkner County Courthouse, Courtroom A. If Courtroom A is unavailable, the committee members will be timely notified of the meeting location by the Secretariat.

Article 5: The following regular Committees are hereby established to serve the Faulkner County Quorum Court: Budget & Finance, Infrastructure, Courts and Public Safety, and Personnel.

Article 6: The Quorum Court and all the Committees thereof shall be procedurally governed by the most current edition of the Democratic Rules of Order.

Article 7: It is hereby recognized that immediate establishment of dates, times, and locations of the regular meetings of the Quorum Court and the Budget and Finance Committee thereof is necessary and is required by state law. Therefore, an emergency is declared to exist, and this Ordinance being necessary for preservation and protection of the public health, safety, and


welfare of Faulkner County, this Ordinance shall be in force and take effect upon passage and publication.




**Section 1: Members**


The Faulkner County Criminal Justice Coordinating Committee shall consist of one District Court Judge, one Circuit Court Judge, one local corrections official, the Prosecuting Attorney, the Sheriff, the City of Conway Chief of Police, the Chief of Police from a smaller precinct in the County, one Justice of the Peace, one medical professional, one mental health professional, one officer with the Department of Community Corrections. In the event that any of these members cannot be present, a designee may be substituted.

**Section 2: Duties**

The Faulkner County Criminal Justice Coordinating Committee shall periodically review data and records of local and regional detention facilities collected under §12-12-219 and assist in the access and transfer of this data. The committee shall recommend protocols for the efficient and effective use of local criminal justice resources.

Therefore, an emergency is declared to exist, and this Ordinance being necessary for preservation and protection of the public health, safety, and welfare of Faulkner County, this Ordinance shall be in force and take effect upon passage and publication.



**ORDINANCE 19-06**

BE IT ENACTED BY THE **QUORUM COURT OF FAULKNER COUNTY, ARKANSAS,**  
AN ORDINANCE TO BE ENTITLED: **“AN ORDINANCE PROVIDING FOR THE  
ESTABLISHMENT OF A FLOOD DAMAGE PREVENTION PROGRAM FOR  
FAULKNER COUNTY AND FOR OTHER PURPOSES.”**

**SECTION 1. STATUTORY AUTHORITY**

The Legislature of the State of Arkansas has in Ark. Code Ann. § 14-268-101 et seq., delegated the responsibility of local governmental units to adopt regulations to minimize flood losses. Therefore, the Quorum Court of Faulkner County, Arkansas, does hereby ordain as follows:

**SECTION 2. FINDINGS OF FACT**

- A. The Federal Emergency Management Agency (FEMA) has identified Special Flood Hazard Areas of Faulkner County in the current scientific and engineering report entitled “The Flood Insurance Study (FIS) for Faulkner County Arkansas and Incorporated areas dated March 21<sup>st</sup> 2019, with an effective Flood Insurance Rate Map (FIRM) dated March 21<sup>st</sup> 2019..
- B. These Special Flood Hazard Areas are subject to periodic flooding events that result in loss of life and property, pose health and safety hazards, disrupt commerce and governmental services, and cause extraordinary public expenditures for flood protection and relief, all of which adversely affect the public health, safety and general welfare.
- C. These periodic flooding events are exacerbated by the cumulative effect of floodplain developments which cause an increase in flood heights and velocities, and by the placement of inadequately elevated, inadequately floodproofed or otherwise unprotected structures or uses vulnerable to floods into Special Flood Hazard Areas. Such structures or uses are inherently hazardous to other lands because of their adverse impact on flooding events.
- D. FEMA has also identified additional areas of flood risk within Faulkner County in the current scientific and engineering report entitled “Cadron Watershed, AR Base Level Engineering Results, HUC-11110205,” dated June 2018 and Flood Risk Report Cadron Watershed, AR HUC8 11110205 dated July 2018.

**SECTION 3. STATEMENT OF PURPOSE**

The purpose of this ordinance is to promote the public health, safety and general welfare, to prevent adverse impacts from any floodplain development activities, and to minimize public and private losses due to flooding events in identified Special Flood Hazard Areas. This ordinance advances the stated purpose through provisions designed to:

- A. Protect human life and health;
- B. Protect natural floodplains against unwise development;
- C. Eliminate adverse impacts of necessary floodplain development;
- D. Minimize expenditure of public monies on flood control projects;
- E. Minimize the need for rescue and relief efforts associated with flooding and generally undertaken at the expense of the general public;
- F. Minimize prolonged business interruptions due to flooding events;
- G. Minimize damage to public facilities and utilities such as water and gas mains, electric, telephone and sewer lines, streets and bridges located in Special Flood Hazard Areas;
- H. Minimize future flood blight areas to help maintain a stable tax base; and
- I. Provide for notice to potential buyers when property is in a Special Flood Hazard Area.

#### **SECTION 4. LANDS TO WHICH THIS ORDINANCE APPLIES**

The ordinance shall apply to:

- A. All Special Flood Hazard Areas within the jurisdiction of Faulkner County, and
- B. Areas within the jurisdiction of Faulkner County where Base Level Engineering is available.

#### **SECTION 5. METHODS OF REDUCING FLOOD LOSSES**

This ordinance uses the following methods to accomplish the stated purpose:

- A. This ordinance restricts or prohibits structures or uses in Special Flood Hazard Areas that adversely impact health, safety or property during flooding events;
- B. This ordinance requires protection against flood damage for structures or uses vulnerable to floods at the time of initial construction, or after substantial improvement of the structure, or after substantial damage has occurred;
- C. This ordinance controls the alteration of natural floodplains, stream channels and natural protective barriers which are involved in the accommodation and transport of flood waters;
- D. This ordinance controls floodplain development (structural development, placement of manufactured structures, clearing, grading, mining, drilling, dredging, placement of fill, excavating, watercourse alteration, drainage improvements, roadway or bridge construction, individual water or sewer installations and other activities) which may increase flood damage by increasing flood elevations, flood water velocities, or flood discharge patterns;
- E. This ordinance regulates the construction of flood barriers which unnaturally divert floodwaters or which may adversely impact other lands.

**SECTION 6. FLOOD DAMAGE PREVENTION CODE ADOPTED BY REFERENCE**

There is hereby adopted by reference a “Flood Damage Prevention Code for Faulkner County, Arkansas,” dated February 26, 2019. The code shall include:

- ARTICLE 1 DEFINITIONS
- ARTICLE 2 ADMINISTRATION
- ARTICLE 3 PROVISIONS FOR FLOOD HAZARD REDUCTION

A copy of the referenced code shall be filed in the office of the County Clerk, and shall be available for inspection and copying by any person during normal office hours.

**SECTION 7. ABROGATION AND GREATER RESTRICTIONS**

This ordinance does not repeal, abrogate, or impair any existing easements, covenants, or deed restrictions. Whenever there is a conflict or overlap between this ordinance and another ordinance, easement, covenant, or deed restriction, the instrument with the more stringent restrictions applies.

**SECTION 8. INTERPRETATION**

In the interpretation and application of this ordinance, all provisions must:

- A. Be considered as minimum requirements;
- B. Be liberally construed in favor of the governing body; and
- C. Be deemed to neither limit nor repeal any other powers granted under State statutes.

**SECTION 9. WARNING AND DISCLAIMER OF LIABILITY**

The degree of flood protection required by this ordinance is considered reasonable for regulatory purposes. Documented scientific and engineering data form the basis for these requirements. On rare occasions, flooding events greater than those considered for this ordinance will occur. In addition, flood heights may increase over time due to man-made or natural causes. This ordinance does not imply that land outside Special Flood Hazard Areas will be free from flooding, nor that strict adherence to this ordinance protects uses permitted within Special Flood Hazard Areas from all flood damages. This ordinance specifically does not create liability on the part of the community, nor any official or employee of the community, for any flood damages that result while strictly following this ordinance, or from any lawful administrative decision made under the provisions of this ordinance.

## **SECTION 10. COMPLIANCE**

Constructing, locating, substantially altering or changing the use of any structure or land after the effective date of this ordinance requires full compliance with the provisions of this ordinance and all other applicable regulations.

## **SECTION 11. PENALTY FOR NON-COMPLIANCE**

Flood hazards are reduced by compliance with the provisions of this code. Accordingly, enforcement of this ordinance discourages non-compliance and is a recognized mechanism for flood hazard reduction.

- A. The Floodplain Administrator must enforce the provisions of this ordinance and is authorized to:
  - a. Issue cease and desist orders on non-compliant floodplain development projects;
  - b. Notify local law enforcement officers and provide the requisite information and evidence so as to afford them the necessary tools to issue citations for non-compliance;
  - c. Determine the presence of a nuisance and if a nuisance is determined to be in existence, the Floodplain Administrator may petition a court of competent jurisdiction to enjoin the person or entity which owns the property or which is in actual or apparent control of the premises from maintaining the nuisance and the maintenance thereof may be abated. This action is not to be construed as a limitation placed upon any other citizen from filing an action to enjoin and abate the condition;
  - d. Request that FEMA file a 1316 Action (Denial of Flood Insurance) against non-compliant properties; and
  - e. Take any other lawful action necessary to prevent or remedy any instance of non-compliance with the provisions of this ordinance.
- B. It is a violation to fail to comply with any provision of this ordinance.
- C. Any person found, in a court of competent jurisdiction, guilty of violating this ordinance is subject to fines of not more than \$500 per day for each violation; in addition the defendant is subject to payment of all associated court costs and costs involved in the case.

**SECTION 12. SEVERABILITY**

If any court of competent jurisdiction finds that any section, clause, sentence, or phrase of this ordinance is invalid or unconstitutional, that finding in no way affects the validity of the remaining portions of this ordinance.

**SECTION 13. EMERGENCY CLAUSE**

It is hereby found and declared by Faulkner County that severe flooding has occurred in the past within its jurisdiction and will certainly occur within the future; that flooding is likely to result in infliction of serious personal injury or death, and is likely to result in substantial injury or destruction of property within its jurisdiction; in order to effectively comply with minimum standards for coverage under the National Flood Insurance Program; and in order to effectively remedy the situation described herein, it is necessary that this ordinance become effective immediately.

Therefore, an emergency is hereby declared to exist, and this ordinance, being necessary for the immediate preservation of the public peace, health and safety, shall be in full force and effect from and after its passage and approval.

4. In the event a special quorum court meeting is called, then all documents, proposed resolutions and ordinances shall be submitted to the secretariat no less than 24 hours before the date of the special meeting.
5. This ordinance repeals previous ordinances to the extent that they conflict and it is incorporated into the 2019 Organizational Ordinance of this Court.
6. The rule established in paragraph three by this ordinance may be waived by a simple majority of the Court.
7. The need for the above provisions has been recognized as urgent and therefore an emergency thus this ordinance shall be effective upon signing.



**BE IN ENACTED BY THE QUORUM COURT OF THE COUNTY OF FAULKNER, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED: AN ORDINANCE TO ESTABLISH FEES THAT SHALL BE CHARGED FOR MAINTAINING AND KEEPING PRISONERS OF ALL OTHER GOVERNMENT UNITS, TO DIRECT AND AUTHORIZE THE COLLECTION OF SAME BY THE COUNTY JUDGE, TO REPEAL COUNTY QUORUM COURT ORDINANCE 80-7, ORDINANCE 92-20, ORDINANCE 93-24, AND TO DECLARE AN EMERGENCY, AND FOR OTHER PURPOSES.**

- SECTION 1: Faulkner County Quorum Court Ordinance 80-7 and Ordinance 92-20, and Ordinance 93-24 are hereby repealed in their entirety and replaced with the following.
- SECTION 2: In absence of a written contract regarding jail costs between Faulkner County and any municipality, such agreement having been approved by the Faulkner County Quorum Court, the Faulkner County Sheriff will levy fees for the provisions of law enforcement administrative support services to all other governmental units pursuant to A.C.A. §12-41-506. Where a written contract between the County and a particular government unit exists, the rate established in the written contract will be levied and charged by the Sheriff. The Faulkner County Sheriff shall levy his per diem confinement costs to other units of government when any Faulkner County confinement of prisoners from other units of government occurs.
- SECTION 3: A “prisoner” shall mean those offenders who are arrested by municipal law enforcement officers and delivered to the county jail for incarceration, from the point of intake until (a) charging on a felony offense, or (b) sentencing on a misdemeanor offense, or (c) release on a municipal ordinance violation. A “government unit” shall mean the state, county, municipality or other government body that has issued an arrest warrant for the prisoner or is responsible for the underlying criminal charges of the prisoner.
- SECTION 4: It shall be the obligation of the Faulkner County Sheriff’s Department to maintain reports containing the name of each prisoner, the governmental unit committing the prisoner and the number of days or parts thereof each prisoner is incarcerated in a Faulkner County Detention Facility.
- SECTION 5: The Faulkner County Sheriff’s Department shall charge and collect per diem costs of \$44.00 per day for adults and \$90.00 per day for juveniles, per prisoner per day or any part thereof for any and all prisoners incarcerated by any other governmental unit in a Faulkner County Detention Facility. Per diem costs are subject to recalculation at any time and solely at the option of Faulkner County.

SECTION 6: All funds collected pursuant to this ordinance shall be accounted for and turned over to the County Treasurer as they are received and shall be deposited by said County Treasurer into the General Fund.

SECTION 7: All fees shall be due and payable by the 10<sup>th</sup> day of the succeeding month in which billed. If any governmental unit shall neglect, fail or refuse to pay the fee for prisoners as charged by the office of County Judge, Faulkner County may bring an action to collect such fees.

SECTION 8: Medical or dental treatment shall be provided to any prisoner as required in order to safeguard their physical and mental well-being. Treatment costs shall be billed directly to the prisoner and/or the governmental unit responsible for the prisoner.

SECTION 9: If any portion of this ordinance shall be subsequently held invalid, the remaining parts thereof shall remain in full force and effect.

SECTION 10: It is hereby recognized that immediate establishment of dates, times, and locations of the regular meetings of the Quorum Court is necessary and is required by state law. Therefore, an emergency is declared to exist, and this Ordinance being necessary for preservation and protection of the public health, safety, and welfare of Faulkner County, this Ordinance shall be in force and take effect on January 1, 2020 upon passage.

**ORDINANCE 19-48**

**Be it enacted by the Quorum Court of Faulkner County, State of Arkansas. An Ordinance to be entitled: An appropriation Ordinance to establish the annual operating budget for calendar year 2020.**

**Section 1: ANNUAL BUDGET ADOPTED BY REFERENCE.**

The annual budget for calendar year 2020 identified as "2020 Annual Budget, Faulkner County, Arkansas", dated December 17, 2019 is hereby adopted by reference. A copy of said budget shall be filed in the Office of the County Clerk and shall be available for inspection and copying by any person during normal business hours.

**Section 2: NONRESTRICTED EXPENDITURE CATEGORIES.**

Expenditures of funds appropriated by this Ordinance shall not be restricted to the line item expenditure codes comprising the four major categories of expenditures - Personal Services, Supplies, Other Services and Charges and Capital Outlays, but shall be restricted to office/departmental expenditures.

**Section 3: EXPENDITURE RESTRICTED TO SPECIFIED FUNDS.**

No expenditure of appropriated funds shall be made from any fund other than the fund specified in the Ordinance or an amendment thereto.

**Section 4: TRANSFERS.**

Any transfer of monies between the various funds of the County or between the four major categories of expenditures - Personal Services, Supplies, Other Services and Charges, Capital Outlays - shall be made only with prior approval of the Faulkner County Quorum Court. Provided, however, all transfers budgeted for in the annual budget shall be exempt from the provisions of this section.

**Section 5: REPEALER.**



**Section 6: EFFECTIVE DATE.**


