(b) The quorum court of each county that has a certified county coroner is authorized to fix by ordinance the annual salary of a **certified county coroner** within the schedule of maximum salaries under § 14-14-1204. (c) Beginning September 1, 2017, and on each September 1 thereafter, the compensation schedule prepared under § 14-14-1210(c) shall reflect a separate maximum annual salary for a certified county coroner with a salary adjustment made under subsection (b) of this section and § 14-14-1204(i).
