

PROPOSED RESOLUTION 23 -07

A RESOLUTION CALLING FOR AN ELECTION AND PLACING A BALLOT REFERENDUM TO THE PEOPLE DURING THE GENERAL ELECTION IN FAULKNER COUNTY, ARKANSAS, ON THE QUESTION OF INCREASING FIRE DUES FOR THE PINE VILLAGE VOLUNTEER FIRE DEPARTMENT; AND PRESCRIBING OTHER MATTERS PERTAINING THERETO.

WHEREAS: The Quorum Court, after a request was filed by the Pine Village Volunteer Fire Department, decided on _____, that it is appropriate to call for an election on the issue of the levy of the volunteer fire department dues; and

WHEREAS: The Quorum Court is charged with the responsibility to request an election on the issue of the levy of volunteer fire department dues; and

NOW, THEREFORE, BE IT RESOLVED BY THE QUORUM COURT OF FAULKNER COUNTY, ARKANSAS, THAT:

Article 1: That there be, and is hereby called, an election to be held on March 5 2023, at which election there shall be submitted to the electors of the Pine Village Volunteer Fire Department Area ESN 318 the question of the levy of Volunteer Fire Department Dues.

Article 2: That the question of an increase of the levy of Volunteer Fire Department Dues for the Pine Village Volunteer Fire Department area ESN 318 shall be placed on the ballot for the election in substantially the following form:

Vote on the measure by placing an "X" in the square opposite the measure either for or against:

ELECTION OF THE PINE VILLAGE VOLUNTEER FIRE DEPARTMENT

An election to consider the dues levied by the Pine Village Volunteer Fire Department to be collected annually in the respective amounts of up to the following amounts:

- A. Improved residential property including attached, unimproved lands up to twenty (20) acres:
 - a. Residences (including mobile housing, RV Campers, etc., used as detached living space) - \$60 per year.
 - b. Noncommercial building used primarily for business purposes - \$60 per building per year.

- B. Improved commercial or business property included attached, unimproved lands up to twenty acres:
 - a. Buildings under 5000 square feet - \$150 per building per year;
 - b. Buildings 5000 square feet to 10,000 square feet - \$200 per building per year;
 - c. Buildings over 10,000 square feet - \$350 per building per year;
 - d. Residences on such premises - \$60 per residence per year.
- C. Apartment buildings included attached, unimproved lands up to twenty acres - \$45 per unit per year.
- D. Mobile homes or RV parks including attached, unimproved lands up to twenty acres - \$60 per improved space meant for occupation per year.
- E. Unimproved lands exceeding 20 acres attached to improved residential, commercial or business property - \$0.10 per acre per year.
- F. Lots or unimproved property not attached to improved residential, commercial or business property - \$15 per platted lot or parcel per year.

Article 3: That the election shall be held and conducted and the vote canvassed and the results declared under the law and in the manner now provided for county elections unless otherwise provided in Title 26, Chapter 74, Subchapter 2 of the Arkansas Code of 1987 Annotated (the "Authorizing Legislation") and only qualified voters of the County shall have the right to vote at the election.

Article 4: A copy of this Resolution shall be provided to the Faulkner County Board of Election Commissioners so that the necessary election officials and supplies may be procured. The Commissioners and County Judge are authorized and requested to take prompt actions in compliance with A.C.A. §26-74-209 in the event the measure is approved by the electors.

Article 5: That the results of the elections shall be proclaimed by the County Court, and this Proclamation shall be published one time in a newspaper having general circulation in the County.

Article 6: That the County Judge and Quorum Court, for and on behalf of the County, be, and they are hereby authorized and directed to do any and all things necessary to call and hold the election as herein provided and, if the levy of the Volunteer Fire Department dues is approved by the electors, to cause the Volunteer Fire Department Dues to be collected in accordance with the Authorizing Legislation, and to perform all acts of whatever nature necessary in a timely fashion to carry out the authority conferred by this Ordinance.

Article 7: That all ordinances and/or resolutions and parts thereof in conflict herewith are hereby repealed to the extent of such conflict.

NOW, THEREFORE BE IT RESOLVED BY THE QUORUM COURT OF THE COUNTY OF FAULKNER, STATE OF ARKANSAS, THAT THIS BODY CALLS AN ELECTION FOR THE ELECTORS OF THE AREA ESN 318 TO APPROVE THE RECENTLY PASSED LEVY OF VOLUNTEER FIRE DEPARTMENT DUES.
