Absentee ballots will be processed and canvassed beginning October 29, 2024, and will continue each day after as needed. Absentee ballots will be opened and canvassed on November 5, 2024.

Any objections to appointed election officials shall be made in writing to the Faulkner County Election Commission, 801 Locust St, Conway, AR, 72034. An objection that an official is a spouse of a county election commissioner, a county party chair, or a spouse of a county party chair must be filed within 7 days of October 11. An objection that an official is married to a candidate or related to a candidate within the second degree of consanguinity must be made within 10 days of October 11.

Greenbrier School District 40.90 Mill School Tax The total rate proposed above includes the uniform rate of tax (the "Statewide Uniform Rate") to be collected on all taxable property in the State and remitted to the State Treasurer pursuant to Amendment No. 74 to the Arkansas Constitution to be used solely for maintenance and operation of schools in the State. As provided in Amendment No. 74, the Statewide Uniform Rate replaces a portion of the existing rate of tax levied by this School District and available for maintenance and operation of schools in this District. The total proposed school tax levy of 40.90 mills includes 25.0 mills specifically voted for general maintenance and operation and 15.90 mills voted for debt service previously voted as a continuing levy pledged for the retirement of existing bonded indebtedness. The surplus revenues produced each year by debt service millage may be used by the District for other school purposes. The total proposed school tax levy of 40.90 mills represents the same rate presently being collected.

Pulaski County Special School District 40.7 Mill School Tax The total rate proposed above includes the uniform rate of tax (the "Statewide Uniform Rate") to be collected on all taxable property in the State and remitted to the State Treasurer pursuant to Amendment No. 74 to the Arkansas Constitution to be used solely for maintenance and operation of schools in the State. As provided in Amendment No. 74, the Statewide Uniform Rate replaces a portion of the existing

rate of tax levied by this School District and available for maintenance and operation of schools in this District. The total proposed tax levy of 40.7 mills includes 25.0mills specifically voted for general maintenance and operation, 0.9 mill voted for dedicated maintenance and operation dedicated specifically for technology purposes, and 14.8 mill voted for debt service previously voted as a continuing levy pledged for the retirement of existing bonded indebtedness. The surplus revenues produced each year by debt millage may be used by the District for other school purposes. The total proposed school tax levy of 40.7 mills represents the same rate presently being collected.

Quitman School District 36.00 Mills School Tax The total rate proposed above includes the uniform rate of tax 25.0 mills (the "Statewide Uniform Rate") to be collected on all taxable property in the State and remitted to the State Treasurer pursuant to Amendment No. 74 to the Arkansas Constitution to be used solely for maintenance and operation of schools in the State. As provided in Amendment No. 74, the Statewide Uniform Rate replaces a portion of the existing rate of tax levied by this School District and available for maintenance and operation of schools in this District. The total proposed school tax levy of 36.00 mills includes 26.24 mills specifically voted for general maintenance and operation and 9.76 mills voted for debt service previously voted as a continuing levy pledged for the retirement of existing bonded indebtedness. The surplus revenues produced each year by the debt service millage may be used by the District for other school purposes. The total proposed school tax levy of 36.00 mills represents the same rate presently being collected.
